

### **Close Quarter Standards**

RULES: Practical Shooting Handbook, Latest Edition COURSE DESIGNER: John Wells

**START POSITION:** Standing in appropriate shooting box facing targets with both wrists above respective shoulders in surrender position. Handgun is loaded and holstered as per ready condition in rule 8.1.1 and 8.1.2.

#### **STAGE PROCEDURE**

**CM** 99-46

- String 1. Upon start signal, from Box A, engage T1-T3 with only two rounds per target, then make a mandatory reload and from Box A re-engage T1-T3 with only two rounds per target.
- String 2. Upon start signal, from Box B, engage T1-T3 with only two rounds per target using strong hand only.
- String 3. Upon start signal, transfer gun to weak hand and from Box C engage T1-T3 with only two rounds per target using weak hand only.
- Jams may be cleared with both hands.


#### SCORING

**SCORING:** Virginia Count, 24 rounds, 120 points **TARGETS:** 3 IPSC

**SCORED HITS:** Best 8/paper

START - STOP: Audible - Last shot

**PENALTIES:** Per current edition of USPSA Practical Shooting Handbook. Failure to perform mandatory reload will result in one procedural penalty per shot fired.



**SETUP NOTES:** All boxes are 3 feet by 3 feet. Set paper targets to 5 feet high at shoulders.





<b>STAGE PROCEDURE</b> On signal, draw and engage T1-T6 with two (2) rounds each and knock down PP1-PP6. Targets may be engaged from Box A. 

**SETUP NOTES**: Setup on near south end of East Bay (cover). Box A should be about 10 feet in front of cover. Setup Stage 4 inside Star first in north end of East Bay. Set PP1-PP4 at least 3 feet behind paper targets to avoid splatter. Set t1-T3 and T8-T10 back as far as possible to avoid being able to engage PP/paper targets in middle alleys at the same position.





**SETUP NOTES**: Setup first in north end of East Bay (cover). Texas Star is 8 yards from Fault Line and as close to back berm as possible. Set walls far enough apart to force shooter to move. May add 'wings' to front of wall.

RO NOTES: Watch for Foot Faults.
